§ 1

1. Under the terms of the Caravan Rental Regulations of Fabryka Przyczep Niewiadów sp. z o.o. the Rental Company gives to the Renter(s) for use in the time period a caravan Niewiadów owned by the Rental Company, model:..... with the registration number:.....
2. The caravan is insured under mandatory third party liability insurance and voluntary comprehensive insurance with the company:..... and is covered by policy number: All incidents of liability from the use of the caravan and damage to the caravan should be immediately reported to the insurer at the telephone number: (incidents within the country) and telephone number: (incidents abroad) and to the Rental Company at the telephone number:, from 8:00 a.m. to 3:00 p.m.
3. Renter(s) declare that prior to the conclusion of the agreement they have become familiar with the Regulations referred to in paragraph 1, accept their content and adopt them for use. The Regulations constitute an appendix to the agreement.

§ 2

Renter(s) declare, that they:

- a. have familiarized themselves with the technical condition of the caravan and its equipment and does not raise any objections to it;
- b. as a result of the instructions carried out by the Rental Company prior to the conclusion of the agreement, have familiarized themselves with the principles of safe and consistent with the instructions usage of the caravan and its equipment,
- c. will not use the caravan under this agreement on the territory of: Belarus, Moldova, Russia and Ukraine.

§ 3

The Renter is to return the trailer indicated in § 1 on the day of, at the place of conclusion of this agreement, i.e. in Tomaszow Mazowiecki, 141-147 Piaskowa St., otherwise he will be charged with a contractual penalty and the Police will be notified, under the conditions specified in the Regulations indicated in § 1 item 1.

§ 4

The Caravan was released to the Renter on the date of this agreement, together with a set of keys, the equipment indicated in the Caravan Handover Protocol and the operating instructions for the electrical/gas equipment constituting its equipment, which the Renter hereby acknowledges. The Caravan Handover Protocol is attached to this agreement.

§ 5

The agreement is prepared in two identical copies, one for each party.
